MEMO OF UNDERSTANDING RE: KASHRUTH REDWOOD HILL FARM/ORC

The Orthodox Rabbinic Certifiers of San Francisco (ORC) is prepared to enter into an agreement with your company for Kashruth supervision.

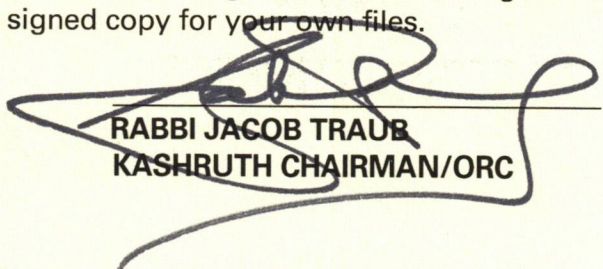
This agreement will cover those dairy products listed in the Kashruth Certificate produced at your Sebastopol, CA plant **ONLY**. It takes into consideration only the present processing and ingredients used. Any changes in ingredients or additional products to be labeled as Kosher must first be cleared with the ORC, giving us ample time to investigate for suitability. We will, of course, work closely with you in attempting to incorporate any new process or product within the framework of Kashruth.

We will, from time to time have our representative inspect the facility and its production. On those occasions, we will bill only for round trip mileage from our home base in San Francisco and your plant in Sebastopol at the rate of \$.75 per mile. The annual endorsement fee for Kashruth certification will be at the rate of \$5,250.

This endorsement entitles you to use the logo of the ORC on your label and approved packaging. We will, on your behalf, answer any and all inquiries and assist you in publicizing your product as Kosher.

We are enclosing this Memo for your signature. Please sign and return one signed copy to our office for our files, while keeping one signed copy for your own files.

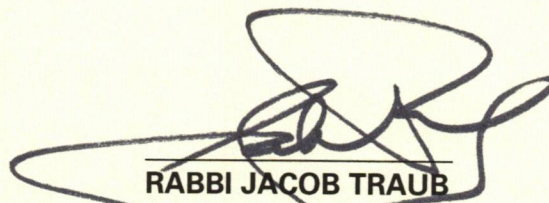

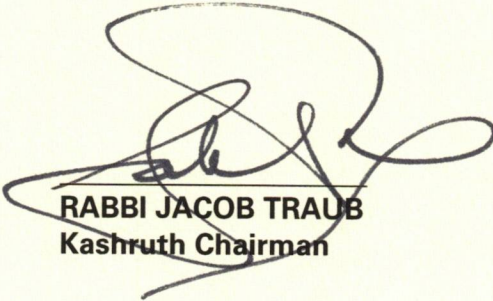
